## FINANCIAL ARRANGEMENTS: SUPPLY FEE, TUITION & LATE PICK-UP

**Supply Fee:** Upon acceptance, a \$40 non-refundable annual supply fee is due. \_\_\_\_\_ (Initials)

**First Month's Tuition:** Each student's first month's tuition is required upon acceptance to secure space. (Full-Time security fee: \$235, Part-Time security fee: \$117.50; Hillsborough Year Round security fee: \$176.25) This fee is non-refundable. \_\_\_\_\_ (Initials)

**Tuition: Full time students on traditional school calendars** will pay monthly tuition divided into 9 equal payments of \$235 per student, September through May. There is no monthly tuition for August or June. **Full time students at Hillsborough Year Round** will pay quarterly tuition of \$528.75 each quarter (or 12 equal payments of \$176.25 per student, July 2012 – June 2013) to coincide with the school cycles at HES. After school will be available year round.

The daily rate for **part-time elementary students** is \$15 per day. Students may be enrolled as 3-day part-time (Monday, Wednesday, Friday) or 2-day part-time (Tuesday, Thursday) based on availability. Part-time enrollment is billed on a monthly basis and part-time tuition is determined by the school calendar.

**Middle School rates are as follows:** \$10 per day (**part-time**) or **\$165 per month (full-time)** if student rides school bus to Chestnut Ridge; **\$12.50 per day (part-time)** or **\$195 per month (full-time)** if student rides Chestnut Ridge transportation. Part-time students must enroll for specific days and will be billed monthly.

### FOR ALL STUDENTS

1. **Tuition is due monthly by the 5<sup>th</sup> of each month.** After School invoices will run monthly. A late payment fee of \$20 will be assessed to the camp account on the 6<sup>th</sup> of each month. The courtesy of one month's notice is requested for any child discontinuing the program. \_\_\_\_\_ (Initials)

2. **Late pick-up fees:** After School care ends daily at 6:00 pm. Late pick-up fees will be assessed to the camp account as follows: \$10 Late pick-up fee if pick-up is 6:01 – 6:10 pm. Additional \$1 per minute for every minute past 6:10 pm. Late pick-up fees will appear on the monthly invoices and are due upon invoice receipt. \_\_\_\_\_ (Initials)

## **Teacher Workdays, Holidays and Intersession Camps (AS Special Camps):**

Camp day is 7:30am – 6:00pm. Campers should pack a lunch and have a bag with water bottle and change of clothes. As with After School, toys from home should NOT come to teacher workdays, holidays, or Intersession camps. The registration deadline for Teacher Workday, Holiday & Intersession Camp is **ONE WEEK** prior to the start of said camp. If you are registering within 7 days of the camp start, your account will be assessed a \$10 Late Registration Fee.

**Full payment for registered “AS Special Camps” is due at the time you register. We require a 2-business day notice if you must cancel any part of your camp registration.** This notice will allow us to offer the camp space to other campers and/or make staffing adjustments. In the event of cancellation with at least a 2-business day notice, a refund (**less \$15 per registered day administrative fee**) will be processed. Cancellations without the required notice will NOT be refunded. If the camp is canceled by Chestnut Ridge, a full refund will be processed.
